# Spinal Cord Injury Compensation Claims

Spinal cord injury compensation claims are legally complex and require a broad range of skills, knowledge and experience.

Not all firms and not all solicitors have this expertise. This guide is to help you choose the right solicitor to handle your compensation claim.

### How Do I Choose?

There are only about 300 claims made each year in the UK. So finding a firm of solicitors with genuine experience in spinal cord injury claims can be difficult.

Many firms are prepared to 'have a go' but this can result in inexperienced solicitors appointing the wrong 'experts', allowing vital evidence to be destroyed or seriously underestimating the value of a claim. These mistakes leave patients undercompensated.

# **Four Important Questions**

- 2. What level of compensation will I receive?
- 3. How long is it all going to take?
- 4. What is it going to cost me?

Then ask yourself whether the solicitor instills confidence and makes you feel comfortable that your case is in good hands.

# **Additional Questions**

Look for a solicitor that only handles spinal cord injury claims and has a solid track record. Ask them:

- How many spinal injury cases they have dealt with?
- What the outcomes of those cases were?
- How quickly those cases were resolved?
- Which experts and spinal cord injury professionals they are in contact with that could help with your case?
- How your case and rehabilitation would be paid for?

Over the last 10 years

We have helped with fundraising for equipment such as excoskeletons. # **Checklist For Choosing A Specialist Solicitor**

- Seek recommendations from people you trust but remember that choosing a solicitor is <u>your</u> choice, not anyone else's
- Meet with more than one solicitor to find out whether you feel comfortable with them and how they can help you. This initial meeting should be free of charge
- Extend your search beyond local solicitors. Spinal injury claims are extremely specialised cases and good solicitors will have a national reach
- Don't assume that bigger firms and dedicated practices are better than smaller niche ones

Above all, take the time to make the right choice for you. Claiming compensation after a spinal cord injury is likely to take at least two years or more to conclude so don't be afraid to interview solicitors to get the right professional to support you and your family.
